French into English.

Candidates who, at the Examination for Associates of Arts have passed in the above subjects, are admitted as Undergraduates.

BOARDING DEPARTMENT.

The charge for Board in the family of the Principal, who resides in the College, is \$3.00 per week including room, fuel, lights and washing. Every room is furnished with table, stand, mirror, chairs, lamp, bedstead and mattrasses. All other necessary articles, such as pillows, blankets, towels; &c., students provide for themselves. Twelve articles are allowed weekly in the wash.

A small deposit is required of every student, which is refund d at the close of the term, if room and furniture have been properly taken care of. Tenants of rooms being responsible for damage and defacing done therein during their occupancy of them.

PUBLICAND FAMILY WORSHIP.

The board of Trustees is composed of clergymen and laymen of several evangelical denominations; and the design of its management is to conduct successfully a higher institution of learning on the basis of Christian union. All the students attend religious exercises in the lecture room of the College every morning, except Saturday and Sunday, and the boarders attend family worship every morning and evening. Careful attention is given to the formation of good habits. As parents may direct, pupils attend public worship and sabbath school at the English church, Methodist, Congregational, Presbyterian or elsewhere.

CHAPTER XI.

General University Meetings and other Meetings in University Buildings.



I.—In the case of all General Meetings appointed by the University, the Principal, or in his absence, the Vice-Principal, shall have power to make such arrangements and to secure such assistance as he may deem necessary for the preservation of order, subject to the approval of the Governors as to any expense that may be involved.

II.—The Principal may, if necessary, call upon the Deans of the several Faculties, or in their absence any of the Professors of such Faculties, to co-operate with him in the preservation of order.

III.—In case of any disorder at such meetings the Principal and the Deans of the Faculties shall form a court of inquiry to ascertain the offenders; and they may either remit the dealing with such offenders to the Faculties to which they belong, or may report to the Corporation.

IV.—The use of any Building or room of the University shall not be granted by the Principal or Faculties to Societies not consisting wholly of members of the University, or to persons not being members of the University or for purposes not connected with the objects of the University, except by special vote of the Corporation.

V.—In case of the use of any room or building being desired for any special meeting or for the regular Meetings of any University Society, the application shall be made in writing to the Principal and to the Dean of the Faculty ordinarily using or having charge of the room or building, and shall be signed by at least three members of the University who shall be held responsible for the character and order of such meeting or meetings, and shall make such provisions as may be required by the Principal or the Faculty, in the interest of the University, for the character and order of such meeting or meetings, for the conduct of visitors admitted thereto, and for the expenses involved.

CHAPTER XI.

General University Meetings and other Meetings in University Buildings.


I.— In the case of all General Meetings appointed by the University, the Principal, or in his absence, the Vice-Principal, shall have power to make such arrangements and to secure such assistance as he may deem necessary for the preservation of order, subject to the approval of the Governors as to any expense that may be involved.

11.—The Principal may, if necessary, call upon the Deans of the several Faculties, or in their absence any of the Professors of such Faculties, to co-operate with him in the preservation of order.

III.—In case of any disorder at such meetings the Principal and the Deans of the Faculties shall form a court of inquiry to ascertain the offenders; and they may either remit the dealing with such offenders to the Faculties to which they belong, or may report to the Corporation.

IV.—The use of any Building or room of the University shall not be granted by the Principal or Faculties to Societies not consisting wholly of members of the University, or to persons not being members of the University or for purposes not connected with the objects of the University, except by special vote of the Corporation.

V.—In case of the use of any room or building being desired for any special meeting or for the regular Meetings of any University Society, the application shall be made in writing to the Principal and to the Dean of the Faculty ordinarily using or having charge of the room or building, and shall be signed by at least three members of the University who shall be held responsible for the character and order of such meeting or meetings, and shall make such provisions as may be required by the Principal or the Faculty, in the interest of the University, for the character and order of such meeting or meetings, for the conduct of visitors admitted thereto, and for the expenses involved.

APPENDIX.

COLLEGE GROUNDS.

Under the regulations of the Governors, restricting the use of the exercise grounds to College clubs, and until permanent arrangements can be made in connection with a new gymnasium on the grounds, the following rules are in force:—

- I. The membership of all clubs using the grounds must consist exclusively of members of the University.
 - 2. No damage must be done to fences, trees, grass, etc.
- 3. All clubs desiring to use the ground in the time of the statutory college session, i.e., from September 1st to May 1st, must register their officers, objects, rules and time desired, in the Principal's office, on or before September 20th in each year, when rights and privileges will be assigned to them.
- 4. Clubs desiring to use any portion of the grounds in the summer vacation, that is, from May 1st to September 15th, shall register as above on or before April 1st.
- 5. No clubs not so registered can be recognized, nor any right of students not organized in regular clubs.
- 6. No club has any right to invite strangers, except by special permission of the Board of Governors.
- 7. The University Athletic Association may use the grounds for the training of its members from September 1st to date of the College sports, at such times as may be necessary. Tickets shall be furnished to students so in training.
- 8. All the above privileges are subject to be revoked at any time by resolution of the Governors.

CHAPTER VIII OF THE STATUTES.

Embodying the amendments proposed by the Committee appointed by Corporation on 22nd Feb., 1899, to draft the amendments necessitated by the establishment of new degrees, etc.

The following Sections 1, 7, 8, 9, 14, and 18-22, inclusive (marked "Old" in the margin), are the existing Sections 1, 3, 5, 6, 10-16, with a few slight verbal alterations.

Sections 2-6, 10-13, 15-17, all inclusive (marked "New" in the margin), are new Sections, and replace the existing Sections 2, 4, 7-9.

- B.A. 1.—Students who shall have completed the Regular Course of Study in Arts, shall have passed the prescribed examinations during the Course, and also the special examinations for Graduation, and shall have performed such exercises as may be prescribed to that end,—the whole to the satisfaction of the Faculty of Arts, and also of any other Examiners whom the Corporation may associate with that Faculty,—shall be entitled to the Degree of Bachelor of Arts.
- M.A. 2.—Bachelors of Arts of at least one year's standing, who shall have taken for one year a Graduate Course of Study in Arts in the University previously submitted to and approved by the Faculty of Arts, shall have passed an examination at the end of the year, shall, if required by

the Faculty, have presented a satisfactory thesis, and shall have performed such other exercises as may be prescribed to that end; or Bachelors of Arts of at least two years' standing, who shall have presented a satisfactory thesis, shall have passed a special examination for the degree, and shall have performed such other exercises as may be prescribed to that end;—the whole to the satisfaction of the Faculty of Arts, and also of any other Examiners whom the Corporation may associate with that Faculty—shall be entitled to the Degree of Master of Arts.

B.Sc. 3.—Students who shall have completed the prescribed Course of Study in the Faculty of Arts for the Degree of Bachelor of Science, shall have passed the prescribed examinations during the Course, and also the special examinations for Graduation, and shall have performed such exercises as may be prescribed to that end,—the whole to the satisfaction of the Faculty of Arts, and also of any other Examiners whom the Corporation may associate with that Faculty,—shall be entitled to the Degree of Bachelor of Science. The Diploma and the Records of the University shall indicate, in special terms, that the Degree is conferred after a Course of Study within the Faculty of Arts.

(New) 4.—Students who shall have completed the regular Course of Study in the Faculty of Applied Science, shall have passed the prescribed examinations during the Course, and also the special examinations for Graduation, and shall have performed such exercises as may be prescribed to that end,—the whole to the satisfaction of the Faculty of Applied Science, and also of any other Examiners whom the Corporation may associate with that Faculty,—shall be entitled to the Degree of Bachelor of Science. The Diploma and the Records of the University shall indicate,

in special terms, that the Degree is conferred after a Course of Study within the Faculty of Applied Science and the particular branch or branches of Applied Science in which the examination has been passed.

M.Sc.

5.—Bachelors of Arts or Bachelors of Science (Arts) of at least one year's standing who shall have taken for one year a Graduate Course of Study in Science in the Faculty of Arts of the University previously submitted to and approved by that Faculty, shall have passed an examination at the end of the year, shall, if required by the Faculty, have presented a satisfactory thesis, and shall have performed such other exercises as may be prescribed to that end; or Bachelors of Arts or Bachelors of Science (Arts) of at least two years' standing who shall have presented a satisfactory thesis, shall have passed a special examination for the degree, and shall have performed such other exercises as may be prescribed to that end;—the whole to the satisfaction of the Faculty of Arts and also of any other Examiners whom the Corporation may associate with that Faculty-shall be entitled to the Degree of Master of Science. The Diploma and the Records of the University shall indicate, in special terms, that the Degree is conferred after a course of scientific study within the Faculty of Arts.

(New)

6.—Bachelors of Science (Applied Science) of at least one year's standing, who shall have taken for one year a Graduate course of study in the Faculty of Applied Science in the University previously submitted to and approved by the Faculty of Applied Science, shall have passed an examination at the end of the year, shall, if required by the Faculty, have presented a satisfactory thesis, and shall have performed such other exercises as may be prescribed to that end;—or Bachelors of Science (Applied Science) of

at least two years' standing who shall have presented a satisfactory thesis, shall have passed a special examination for the degree, and shall have performed such other exercises as may be prescribed to that end;—the whole to the satisfaction of the Faculty of Applied Science and also of any other Examiners whom the Corporation may associate with that Faculty—shall be entitled to the Degree of Master of Science. The Diploma and the Records of the University shall indicate, in special terms, that the Degree is conferred after a course of study within the Faculty of Applied Science, and the particular branch or branches of Applied Science in which the Examination has been passed.

[Or as an alternative to sections 5 and 6 the following section:

(New)

Bachelors of Arts or Bachelors of Science of at least one year's standing who shall have taken for one year a Graduate Course of Study in the Faculty of Arts or the Faculty of Applied Science of the University previously submitted to and approved by the Faculty, shall have passed an examination at the end of the year, shall, if required by the Faculty, have presented a satisfactory thesis, and shall have performed such other exercises as may be prescribed to that end; or Bachelors of Arts or Bachelors of Science of at least two years' standing who shall have presented a satisfactory thesis, shall have passed a special examination for the degree, and shall have performed such other exercises as may be prescribed to that end;—the whole to the satisfaction of the Faculty of Arts or the Faculty of Applied Science as the case may be and also of any other Examiners whom the Corporation may associate with the Faculty-shall be entitled to the Degree of Master of Science. The Diploma and the Records of the University shall indicate, in special terms, that the Degree is conferred on the recommendation of the Faculty of Arts or the Faculty of Applied Science, as the case may be.

- 7.—Students who shall have completed the Regular B.C.L. (Old) Course of Study in Law, shall have passed the prescribed examinations during the Course and also the special examinations for Graduation, and shall have performed such exercises as may be prescribed to that end,—the whole to the satisfaction of the Faculty of Law, and also of any other Examiners whom the Corporation may associate with that Faculty,—shall be entitled to the Degree of Bachelor of Civil Law; provided always, that a Bachelor or Master of Arts, or an Articled Student with a practising Member of the Bar of Lower Canada, who shall have matriculated in the third year of his Clerkship under such articles. shall be entitled to such Degree after two years' attendance on the said Course of Study, if he shall satisfactorily pass all requisite examinations, and perform all required exercises.
- M.D. 8.—Students who shall have completed the Regular (Old) Course of Study in Medicine, shall have passed the prescribed examinations during the course, and also the special examinations for Graduation, and shall have performed such exercises as may be prescribed to that end,—the whole to the satisfaction of the Faculty of Medicine, and also of any other Examiners whom the Corporation may associate with that Faculty,—shall be entitled to the Degree of Doctor of Medicine and Master of Surgery.
- D.V.S. 9.—Students who shall have completed the Regular (Old) Course of Study in Comparative Medicine and Veterinary Science, shall have passed the prescribed examinations during the Course, and also the special examinations for Graduation, and shall have performed such exercises as may be prescribed to that end,—the whole to the satisfac-

tion of the Faculty of Comparative Medicine and Veterinary Science, and also of any other Examiners whom the Corporation may associate with that Faculty,—shall be entitled to the Degree of Doctor of Veterinary Science.

- D.Lit. 10—Masters of Arts who, being Graduates in Arts of at least five years' standing, shall have distinguished themselves by special research and learning in the domain of literature, shall have presented a satisfactory thesis or published work, and shall have performed such other exercises as may be prescribed to that end;—the whole to the satisfaction of a standing committee consisting of such members of the University as the Corporation may in that behalf appoint—shall be entitled to the Degree of Doctor of Literature.
- D.Sc. 11.—Masters of Arts or Masters of Science or Doctors of Medicine, who, being Graduates of at least five years' standing, shall have distinguished themselves by special research and learning in the domain of Science, shall have presented a satisfactory thesis or published work, and shall have performed such other exercises as may be prescribed to that end;—the whole to the satisfaction of a standing committee consisting of such members of the University as the Corporation may in that behalf appoint—shall be entitled to the Degree of Doctor of Science.
- D.C.L. 12.—Bachelors of Civil Law of at least twelve years' standing, who shall have passed such examinations and performed such other exercises as may be prescribed to that end, shall be entitled to the Degree of Doctor of Civil Law.
- LL.D. 13—Except as provided in Section 17 the Degree of (New) Doctor of Laws shall be given only as an honorary degree.
 - (Old) 14.—Students who shall have completed any Special Course of Study, duly established and maintained in con-

nection with any Faculty or Faculties, and shall have passed the prescribed examinations during such Course, and also the special examinations for Graduation, and shall have performed such exercises as may be prescribed to that end,—the whole to the satisfaction of such Faculty or Faculties, and also of any other Examiners whom the Corporation may associate with such Faculty or Faculties, shall be entitled to the Degree of Graduate in such Special Course.

- (New) 15.—The Degree of Graduate in Civil Engineering or the Degree of Bachelor of Applied Science heretofore granted by this University may on application be exchanged by the Corporation for that of Bachelor of Science, and every Graduate holding that Degree so given in exchange shall rank as such Bachelor of Science from the date of the Degree so exchanged by him.
- (New) 16.—The Degree of Master of Applied Science or the Degree of Master of Engineering heretofore granted by this University may on application be exchanged by the Corporation for that of Master of Science, and every Graduate holding that Degree so given in exchange shall rank as such Master of Science from the date of the Degree so exchanged by him.
- (New) 17.—Any person who shall have matriculated and attended lectures in any Faculty before the 31st day of January, 1899, shall, in accordance with and subject to the Statutes and the Regulations of the Corporation in force on that date, be entitled to receive any Degree which might have been granted to him in pursuance of such Statutes and Regulations.
- (Old) 18.—Upon the organization of any other Faculty or Faculties, there shall be granted therein such Degrees as by Statute in that behalf shall hereafter be ordained.

(Old) 19.—Graduates of other Universities, desirous of admission to the like Degree in this University, may be so admitted by the Corporation; due enquiry being first made as to their moral character and sound learning, and opportunity given to the several Faculties to make such representation in the premises as they may see fit. Provided always, that, except by unanimous consent, such admission shall not be put to vote until after three months' notice, and shall not be ordered, if as many as five Members of the Corporation shall vote against it.

(Old) 20.—Honorary Degrees may be granted by the Corporation to any persons who may be considered worthy of such distinction; due enquiry being first made, and opportunity given to the several Faculties to make such representation in the premises as they may see fit. Provided always, that, except by unanimous consent, the grant of such Degree shall not be put to vote until after three months' notice, and shall not be ordered, if as many as five Members of the Corporation shall vote against it.

(Old) 21.—The Fees on all Degrees shall be such as from time to time shall be fixed by the Regulations of the Corporation. Such Fees shall always be deposited with the proper officer, before a Degree is conferred; and no Diploma shall be given, until the Degree shall have been conferred.

(0:d) 22.-Degrees in Course may always be refused, if the conduct or character of the Candidate be open to objection.
