


From arrival in Ottawa (from
Brit. Columbia) on Oct. 7th, acting
Director of the Geological Survey, in
Dr Selwyn's absence on leave.
Find it is well understood that this
'absence' is preliminary to Superannuation
& generally understood that I am to
be Dr Selwyn's successor.

As long ago as 1888, Dr Selwyn's
Superannuation & my appointment
as Director of the Geological Survey
were in prospect. Hon Thomas White,
then Minister of Interior informed
me that he had decided upon this & had
obtained Sir John Macdonald's consent
to it, shortly before his death. I had
been in charge of the Geol. Survey for
nearly a year, as Acting Director
during Dr Selwyn's absence about
the Colonial & Indian Exhibition in
1886. In 1887, Mr White sent me
out in charge of the Yukon Expedition,
& in the early part of 1888 I had
been sent to Washington in connection

with the Canada - Alaska Boundary
question, raised during the negotiations
for a new fishing treaty. Nothing
came of my conference at that time
with Dr. Dole, & later, the fishing
arrangement also fell through.
Although Mr. White intimated the
approaching change to me, he apparently
hesitated in taking the final step, &
a few days afterwards fell ill & on
April 21, 1888, died. Thus the
matter ended for the time. In the
summers of 1888 & 1889^{or 1890} I was again
at work in the Southern interior of
British Columbia, but became gradually
involved in the Behring Sea discussion.
Early in 1890, I had written to
Major General Cameron C.B., at Kingston
on some points relating to Canada - Alaska
boundary - he had been at Washington
with Sir Charles Tupper (Senior) in
1888 & added an expression of views
on the Sealing question. This it seems
he forwarded to Sir C. T. Tupper, then

in Washington in connection with
the Sealing Question, who forwarded
a request to me, through the Finance
department, for a precis setting forth
my view of the case. This was the
beginning of my connection with it.
The project of a Commission to
Behring Sea arose & during the
Summer of 1890, while in D.C. I held
myself in readiness to accept a
nomination for that work, in conformity
with an indication that it might
come, - given by Sir C. H. Tupper.
Nothing was done, however, & it was
not till 1891 that I & Sir George
Baden Powell were actually
appointed Commissioners. The diary
of the Commission & of subsequent
visits to Washington (as Commissioners)
to London, to London & Paris, &
again to Washington about the
completion of arrangements for regulations,
are contained in other Nos. books
of mine.

Having understood that Dr Selwyn was
not to return as Director, thus being
great dissatisfaction almost everywhere
with his regime, I mentioned my aspirations
to be his successor to Mr Daly, then
Minister of Interior, saying that I did not
wish it futile to ask friends for
political support, the thing being repellent
to my feelings. Mr Daly answered that
he did not think it necessary, that the
balance of effort would be
practically unanimous with the Cabinet.
On Nov. 9th acting on the suggestion
of Mr Burgess, Deputy Minister of
Interior, I however wrote to Mr Daly
a statement setting out my claims to the
Directorship & received a very kind
reply from him. The necessary papers
for Dr Selwyn's resignation &
my appointment were made out under
Mr Daly's superintendence, & it was
intended that everything should be
completed in good time so as to
enable Dr Selwyn to be notified before

it would be necessary for him to leave
England, his leave of absence expiring
on Jan 5, 1895.

It should be stated that when Dr Selwyn
left he informed several of the
Ministers that he was anxious to be
Sopranointed & that Lord Temple, his
son Percy included, understood that
this was his view. While therefore not
feeling authorized to communicate with
him personally on the subject, I
supposed that he fully realized the
situation.

Sir John Thompson's sudden death in
England upset the plans above
referred to, a new Cabinet had to be
formed under Sir Mackenzie
Bowell, two Orders in Council were
passed for sanction & the result
was that my appointment did not
actually take place till Jan 7, 1895,
when Dr Selwyn was on the Atlantic
or just landing in New York. He
attended a meeting of the Quebec

General Mining Association in
Montreal on the 5th, & in reply to
questions asked that he had heard
nothing of his superannuation, in which
he was technically correct. On the
evening of the 9th he arrived in
Ottawa, with Miss Selwyn & the
next morning turned up at the office.
The situation was a little embarrassing
both for us & for his son Percy
who was acting as my secretary, but
I must say that he took it very well,
although he had apparently forgotten
completely his request for superannuation
already referred to a thought
himself rather hardly treated,
particularly in the matter of wanting
due notice. Under any other
circumstances than those actually
occurring this want of ^{official} notice would
have been inexcusable, but it
could scarcely be helped under the
conditions arising on Sir J. Thompson's

personally was & has always been
most friendly. This he expressed
very fully at the annual dinner of
the Fogar Club which was held
on Jan. 17th & was made the
occasion of a complimentary

a memo on the matter, which, however,
assumed that the 7,000 for boring was to
be charged against the proposed grant of
\$45,000 for Survey work. Minister tells me

revising memo, which he requires on
Saturday morning. Ferraro is good
Friday & same difficulty anticipated
by me in getting assistance for type-
writing etc, in view of proposed visit to
Vancouver.

At Club, before dinner, met all four
members of Newfoundland (Confederation)
delegation, now here. Arrange that they

Evening took of office recording news, as

Good Friday, April 12. Met the
Newfoundland delegates & spent some
time with them, according to appointment,
in Museum. Then, to Montreal by 4:40
train.

April 13, 14, 15, in Montreal. Much
rain nearly all the time. Leave
for Ottawa by 9:10 P.M. train on
15th. Train late, getting in about
2 Am.

Wednesday 17. April. State dinner
& reception at Fort. Houses tonight.

April 18. Meeting of Parliament. Did
not attend at the opening.

April 19. Sent of box of 12 framed
photos. to Lepoint Survey of Photographic

The first thing I noticed when I stepped out of the plane was the fresh air. It felt like a breath of life after being cooped up in a small cabin for hours. The sun was shining brightly, and the birds were chirping happily. I took a deep breath and smiled. This was my chance to see the world from a different perspective.

As I walked through the airport, I saw people rushing to catch their flights. Some were carrying heavy luggage, while others were just carrying a backpack. I noticed a man in a suit looking at his watch, and a woman in a uniform talking to a group of people. The atmosphere was busy and full of energy. I felt like I was part of something big.

My flight was on time, and the pilot was very professional. He gave us a brief overview of the flight and the weather conditions. We took off smoothly, and the view from the window was amazing. The clouds were white and fluffy, and the ground below was a patchwork of green fields and brown roads. I felt like I was flying over a beautiful landscape.

After a few hours of flying, we landed at our destination. The plane taxied to the gate, and the passengers started to disembark. I took my luggage and walked towards the exit. The air was still fresh, and the sun was still shining. I felt like I had reached a new world. I was excited to see what was in store for me.

As I stepped out of the plane, I saw a sign that said "Welcome to [City Name]". I felt like I had arrived at a new home. The people were friendly and helpful, and the scenery was beautiful. I was in luck. This was exactly what I needed. I was going to have a great time.

Apr. 21. Sunday. At office part of day.
Called at W's but found all out.
W & F afterwards called on me at
Bill Chambers.

Apr. 22. Called on Sir Mackenzie
Brewell at 10 Am. Explained state of
boring enterprise to him shortly.
He seemed rather favorably inclined
to providing for its continuance.
Discussed proposed summer work with
view of the work today.

Dr Bell went over in course of conversation on another subject, that Dr Selwyn had at one time asked him to prepare general report on Mineral Resources of Ont. Told him that the same matter had occurred to me, & that he should consider whether he can undertake it & let me know, for certainly it must be done by someone.

April 25: Haven discussed probable plans with nearly all the field men now & got estimates from most. Talk with Dr Bell today on the subject. His words to you & Hudson Bay of an 'Expedition' is organized. If not, to explore country to S. of James' Bay. Asked for a memo. of probable cost of cart, or of working on another of the regular routes N. of Great Lakes.

Very indefinite & full of severalties.
Sent off Geol. Coloured copy for Newlook's work today, at last.

April 26. Sent off Suppl. Estimates for 1894-95 to Minister.

April 27. Estimates returned approved by Minister. Sent them on to Deane's Accountant. Wrote letter to Minister on French translation & publishing. Revising Lyell's report for 1893 etc. etc. W. to Deane with me at Club tonight.

April 28. Sunday. At office a little time in Pen. Eng. writing out notes on Alberta drift at home.

April 29. Drew then Mr. Duff's attention to introduction of Perez Selwyn's salary for the 4 months unpaid, in Suppl. Estimates. This his last chance of getting the money but the Minister must push it through. Also drew attention to fact that with reduced appropriation it would be impossible to take on extra bands this season.

April 30. Sent off explanation of estimates to Minister, by request of his Secretary, Chisholm. — in a hurry. Called on S. S. Dawson, printing Bureau, about work. Decided to get Lewis R. steel done as stone as before, not Copper, as proposed — to save time & money for the moment.

Drafted report on future work of

May 1. Had talk with Giroux on N.W. Eastern Township sheet, on which he is at work. Talk with Tyrrell on his work & with Fletcher, who returned today by my instructions from N.S. Tried to see the Minister at his office about the estimates, but missed him. Extraordinary number of interruptions.

May 3. Call from a Mr Sargent, Sec. of Slough Ck. Reg. Co., Cariboo B.C., who took up a lot of time in the morning. Had written to the Minister yesterday about omission of \$7000 from Estimates for the Athabasca boring operations. Mentioned the matter to him at lunch. He hopes to be able to get it through.

Interview with Eaton, who is pressing for better pay.

May 4. Mr Jack, from N.S., brought in by Dr Ellis. Has a Cheverical Sebene for getting part of land from Govt. for some Company & erecting a building for the Geol. Survey & Museum by the Company as payment.

Told him Seves very glad to take
so much interest in the matter & that
so far as I am concerned he can
take his scheme up as much as
he likes, on his own account. Called
on Minister to explain his R.A.G.
Johnston's position & line of work. He
is pressing through political friends

Brunell, should he leave. His
vacancy should, however, be filled
probably but in the same (statistical)
line.

A very hot day in the Season.

May 6. Minister promised to
come to office at 11 Am. to discuss
arrangements for field work, but
prevented by a meeting of Council.

May 8. Dined at Club tonight with
Mr H. Keipemill, Col Zisdell &
Mr Dixon & other guests.

May 9. Another appointment to see the
Minister, but failed, he having to
go to the Public Accounts Committee.

May 10. Obtained an interview with
the Minister at 11 am. & in about
20 minutes discussed plans for
summer field work. Showed him
general plan of appropriation of money
available. Plan for field parties,
district assistants etc. He offered
obj. whole, also of the limited number of
assistants proposed - all those employed
in previous years. If he sticks to this
we should be able to pull through on
the sum estimated for field work.
Minister authorized steps to be taken to
get the parties in the field. Says we
may have to grant that the Suppl.
Est. for current year will go through.
I spoke also of urgency of arrangements
being made for French translation of
Report now printed & the project of
getting the Parliamentary Printing Committee
to take this over. He has sent my last
memo. on this to Mr Foster.

On return to office told Prof. MacCorm that he could now make his arrangements to leave as soon as he pleases. He is very anxious to get away.

That he consented to his exploring Country S. of James Bay, via Upper Ottawa, if he could do so not to exceed \$1500. otherwise continue work N. of Sudbury. Asked Dr B. to give us his decision on it as soon as possible.

May 11. Informed Baslow & McCannell that they might prepare to take the field as soon as they think advantageous. McCannell tells me that the mining business into which he proposed entering has fallen through. He stays.

the 17th, but get little satisfaction. Then to

Aug. 29. A real gloomy warning & so

about getting the rig ready, but eventually
got off at 10:45, before the others. Stopped
for lunch by the way & found the others
at Sturgeon Crossing, they being gone by another
& shorter road. Day turned fine in P.M.
& so on to Camp at little stream

a state that they could go only by short
stages with frequent rests. Got down to the
Landing at dark, found Mr Seely, wood of
H.B. Co who very kindly pressed me
to stay with him. Thought, however, that
I had better go on to site of boring since
half a mile farther & did so. Found that
Foster had a tent pitched for me &
after a short chat turned in. Boring
is now down some 1500 feet. Along the

out very picking - at the very season they

position of casing. Dine with Mr Leslie
Wood this eve.

The 'oil' spring Scleria & Sclipturus with black mud, no oil. The well unsatisfactory, as the man who dug it is away & the stuff taken out all spread about in a farmyard.

Attended to some commissions of Francis's etc before dinner. Day very cool, with occasional sprinkles of rain.

Sept 5. Had thought I might get help of today to visit a gold mining locality some six miles up the river where they are drifting into the bank. Anxious to see into what formation they are drifting.

Snow in the morning & cold, making the roads barely muddy & altogether an unfit day for any such expedition.

Looking after various matters, particularly






