



Report of the Year 1922

The Prelate of the Order begs to lay before the Members of the Order a Report of the Chapel and also the Accounts of the Fund, with a list of the Subscribers.

ADDITION TO THE CHAPEL.—The Memorial to the late Lord Forrest, Knight Grand Cross, has been placed in position. It will be remembered that the friends of Lord Forrest, after consulting the Architect of St. Paul's, and with the cordial assent of the Dean and Chapter, determined to erect in the Chapel "the Prelate's Throne." A sum exceeding £600 was collected for the purpose, and a small donation from the Chapel Fund was added to it in order to enable the work as estimated to be carried out. But in addition to this, the Dean and Chapter have made a splendid contribution on their part in order to make the

Throne wholly worthy of the Chapel and of the Cathedral. Most valuable oak and carvings of the Wren period have been inserted into the new work, thus increasing the value of the Throne as a work of art in a very marked degree. This old carved wood formed part of the Screen which in old days divided the Choir from the Dome; it was removed many years ago, all the materials being carefully preserved. The Members of the Order are requested, when they visit their Chapel, to note this beautiful addition to the general decoration of the Chapel. The expense of the Fald Stool has been defrayed by the Chapel Fund: but one detail of its decoration has been at present omitted in the hope that some Member or Members of the Order may see their way to contribute to the cost. The full design shows two carved oak figures to stand at the two corners of the Fald Stool. The cost of each figure is £25. A collotype photograph of the Throne has been inserted in each Report.

No one who examines this noble addition to our Chapel can fail to see that it suggests an ideal for the future treatment of all the Stalls. The old Wren Screen at the entrance to the Chapel is surely the guide to all future improvements, and the Reredos, and now the Prelate's Throne, are on the lines of that old Screen. Nothing in this statement, however, must be considered as in any sense a reflection upon the work of the late distinguished Architect of the Cathedral, Mr. Somers Clarke. Twenty years ago he was requested to draw up the plans for the present Stalls, and he was informed at the same time that only a certain amount of money was available for the whole scheme. It was impossible for him under those circumstances to do more than he actually accomplished.

To-day it is a not unreasonable dream of the future that sooner or later all the Stalls may be designed in a richer style, especially if the scheme could be carried

out quite gradually, beginning, of course, with the Royal Stalls—those, namely, of the Sovereign, of the Grand Master, and the Stall at present held by the Duke of Connaught. The years pass; and the Prelate respectfully tells these dreams of his to the Members of the Order.

INTERCESSION.—For the same reason, namely because age advances, it may be pardoned him if the Prelate enters into some detail regarding his own work in the Chapel for the last sixteen years—the hardest work he has had to do and the most treasured and valued by himself.

It seemed natural that he who has been placed in charge of the Chapel and all services connected with the Order should himself remember before God, and individually, every Member of the Order, whether Christian or non-Christian. Moreover, thus to pray for each Member in the Chapel itself. This has actually been done annually, kneeling at the Altar Rail.

It is not unreasonable to hope, and it would surely be the wish of the Members, that this habit may become a tradition in the future. In the belief that it may be so, the following details are given as a guide. It is impossible to be too careful that such prayers should not become conventional, that is, merely a rapid reading over of names. It should be done, if done at all, with full emphasis and all possible knowledge, with pauses, and with an entire absence of hurry. Experience

has shown that if all this is done, it is impossible to pray in such a manner for more than an hour at a time. One hour leaves one completely exhausted. Each Member should form the subject of a special prayer; also the general form of the prayer must be constantly varied to guard against inattention. The name of each Member should be mentioned always twice, sometimes thrice, with full bearing on his work in life and his possible needs at the special time. This system has gradually been evolved, and never more fully than in the past year. It is needless to say that such a work means an effort extended over weeks, if not months. If it is the hardest it is also the most welcome. The Annual Service of the Order seems to crown all such effort, hallowing it as if with a sort of silent approval. The Prelate hopes he may be pardoned for thus entering, for once, into so personal a matter.

The following facts are inserted for the sake more especially of the new Members of the Order.

The Chapel.

The Chapel was dedicated on June 12th, 1906, in the presence of the Sovereign of the Order, King Edward VII., and of the Grand Master, H.R.H. The Prince of Wales, now the Sovereign of the Order, attended by 314 other Members of the Order.

Ever since that day the Chapel has been in constant use in connection with the Order, and every effort is made to connect it with the lives and interests of the Members.

The following details are worthy of note:—

1. The Annual Service of the Order is held on St. George's Day (April 23rd), unless otherwise ordered, with every suitable accompaniment for the purpose of

- giving dignity and beauty to the Service, including the fixing and removal of the Banners of Knights Grand Cross, and at this Service a solemn commemoration is made of all Members who have died since the last Annual Service. The names are read during this Service by the Gentleman Usher of the Blue Rod.
2. Special Services are also occasionally held for the fixing and removal of Banners.
 3. A celebration of the Holy Communion is held in the Chapel at 8 o'clock on every Saint's Day morning.
 4. Memorial Services for departed Members of the Order are held from time to time when applications for such are made to the Prelate of the Order (at the Chancery of the Order, Colonial Office, Downing Street); but such Services require time for arrangement, and the engagements of the Dean and Chapter in the Cathedral have to be considered.
 5. Arrangements are made for Memorials, Arms Plates, and Name Plates in the Chapel, application being made to the King of Arms, at the Chancery of the Order.
 6. The care of the Chapel and of its Services is vested in the Prelate of the Order by Statute, and it may be as well to state that the Prelate alone is authorized to conduct all Services of the Order, whether they are Memorial Services or the more general Services for Members of the Order.

Stalls and Seats in the Chapel.

There are twenty-eight Stalls for Knights Grand Cross. When vacancies occur, such Stalls are offered in turn to Knights Grand Cross in order of seniority.

For Knights Commanders thirty-nine Seats are provided and are allocated in the same manner. Seat No. 34, previously available, has been abolished to make room for the Prelate's Throne.

For Companions there are eighteen Seats.

All Banners of Knights Grand Cross are affixed over the Stalls during a Special Service prepared for the purpose. They are also removed with suitable ceremonial when a Knight dies, and placed upon the Altar, after which they are returned to the family of the deceased Knight.

The St. Paul's Fabric Fund.

It will be remembered that last year it was pointed out to the Members of the Order that the very existence of the Cathedral depended upon immediate action being taken to strengthen the great piers which support the Dome. Nor is St. Paul's an isolated case. We hear on all sides of the anxiety of Chapters of Cathedrals for their edifices. At this time St. George's, Windsor, Lincoln Cathedral, Salisbury Cathedral, and others, are being carefully treated, and at great expense.

The facts about the necessary work at St. Paul's are as follows:

The whole of the first great section of the work, namely, the strengthening of the South Transept, is completed after ten years' unbroken labour, and the girders and scaffolding have been removed.

Four of the remaining six piers which carry the weight of the Dome have been surrounded with scaffolding, and are being carefully examined. Much loose masonry has also been removed from their surface. All this work is being supervised by five engineers and architects, Sir Aston Webb being the Chairman. The original fund needed had been estimated as £70,000. This has all been spent, and a new appeal for £100,000 has been issued on the recommendation of the experts, and it has been supported by the Archbishop of Canterbury, the Bishop of London, and the Lord Mayor of London. Of this sum about £45,000 has been received. About £55,000 is still required.

It is believed that Members of the Order will be glad that this urgent need is again brought to their notice.
