We the undersigned beg to call to your attention a matter of very vital importance in the prosecution of our professional careers It is a matter which is not entirely novel but yet we feel that it is one to which attention should again be given. The Department of Pharmacy of the Faculty of Medicine of our University has been in existance six years but in contradistinction to its sister universities, particularly that of Montreal, McGill has not as yet seen fit to confer a degree of Bachelor of Pharmacy upon those who have graduated from this department.

We can readily perceive that this has possibly been due to the fact that the Department during its embryonic years has feared to advance too rapidly, and was forced to assume due precautionary measures corelative to the situation in which it found itself.

We feel confident however that this incipient stage has been encompassed. The Department has undoubtedly acquired much valuable experience in this matter and possibly have reached the opinion that such a degree is warranted and should be conferred.

We may humbly adduce the fact that this degree would be of incalculable bebefit and value to the students of the Department. The Pharmaceutical Association of the Province of Quebec has repeatedly expressed the statement that the presence of such a

degree would obviate the necessity for the holders thereof to sit for the Assistant Pharmacist's examination. This in itself would be keenly appreciated by the students, not merely because it would relieve the onus of extra work, but rather, because the latter is in reality superfluous and a mere duplication of part of the work taken in the persuance of such a degree.

The existance of a degree would assuredly be the cause of a greater influx of students and graduates to the Department. We feel that the enviable reputation which the Faculty of Medicine holds in the eyes of the medical profession of the world is really incomplete until it has seen fit to dignify its sister profession of Pharmacy with a degree. We feel again, that after three years of intensive study and a complete course of lectures that it is not too much to ask that the students of this Department should be granted a degree as a fitting reward commensurate with the amount of study and labour that has been expended therein.

We express the aspiration that this matter will be given the utmost attention and thought by you and those in whose hands the solution and granting of this petition may lie.
