My dear Doctor Penfield:

Referring to your appeal to the Josiah Macy, Jr. Foundation for assistance, I regret to inform you that at a recent meeting of the Executive Committee it was decided, after careful consideration, that it will be impossible to extend to you a grant in aid of your investigation of the surgical treatment of persistent headaches and the study of nerve endings in the dural sinuses and the intracranial sensitive areas.

This decision has no bearings on the merits of the project which you submitted. In view of the circumstances under which we are now operating, the Executive Committee at its recent meeting adopted a very conservative policy and limited its appropriations to the continuation of the support of research now going on under subvention of the Foundation.

Post-traumatic headache we have learned to treat by spinal and direct insufflation of air in such a way as to relieve the adhesions which occur in these cases in the subdural space. We have relieved a certain group of patients whose headaches were due to increased calcification of the inner table of the skull by incision of the dura and by ligation of the veins next to the longitudinal sinus. We have relieved certain unilateral cases of migraine by superior cervical sympathetomy continued with partial section of the posterior root fibers of the fifth nerve.

In a large number of craniotomies carried out under local anaesthesia we have stimulated various areas within the cranial cavity and, thanks to the patients (co-operation have identified the sensitive areas within the cranial cavity and the site at which such stimulation produced pain.

For the future we have a good deal of work in mind in regard to various types of headache. One specific problem is the study of nerve endings in the sinuses and tracing out more definitely the nerve supply of the intracranial sensitive areas mentioned above. A young man is available and capable of carrying out this work but for whom I must secure a fellowship. As my general budget has been curtailed \$10,000. it is no longer possible for me to take on any new men. Dear Sirs.

I am writing this letter in the hope that you may be interested in some work which we have presented on headache and which we are unable to pursue as completely as possible because of lack of funds.

Because of the large number of operations we have done under local anaesthesia, particularly in epileptic cases, we have outlined fairly completely those areas within the cranial cavity which are really sensitive to pain and have recorded these findings over a period of years. I have a man here who is available to work on the problem. I want him to put in full time which he cannot do unless he has a fellowship. He would study the anatomy of the areas mentioned.

From the clinical point of view our attitude has been that all headaches, if they are clearly understood and severe enough to justify interference, can be cured by radical operation. Our immediate need in regard to these cases of headache is to have a clinical fund which will make it possible to hospitalize some of those people who otherwise find it beyond their means to remain in the Hospital while we continue our studies and treatment.

I hope that I am not bothering you about a problem which comes outside your sphere of interest.
