WE COMMAND you to summon

No. *2005*

Albert J. Daines, of the Town of Lachine dis- trict of Montreal

to be and appear before our said Superior Court, in the Court House, in the city and district of Montreal, within a delay of six days from the date of the service upon *him* of the present writ, when the distance from the place of service to the place where the Court is held does not exceed 50 miles (when the distance exceeds 50 miles, the delay is increased one day for each additional 50 miles; provided always that the delay need never exceed 20 days, whatever the distance), to answer the demand of

La Bank of Montreal, a banking corporation duly incorporated according to law, and having its head office & place of business in the City & district of Montreal

contained in the hereto annexed declaration.
