 could do if personally present, with full power of substitution and revocation, here-
 by ratifying and confirming all that our said attorney or his substitute
 shall lawfully do or cause to be done by virtue hereof.

I have written 2 letters

to Lachine and have received no answer to either
of them on what account ^(do) I do not know but we will
let them pass. ~~and~~ When you was here last summer you
wished Jane and me to grant you a power of Attorney in our
behalf we being and residing in another State ~~so~~ I could not
get this Power of Attorney untill 7 Oclock in the morn-
ing and had to hurry to get to the boat and was there
the first day you proposed to meet me at my Sister's
I would have given you the power of attorney on the 3rd of
August but on the 4th I would not having read and re-
read it I thought there was some plan laid to keep Jane
out of her money but since then I see that it is for the
Lachine or Montreal & New York Rail Road which was
to pass therefore the reason I did not send this to you
before this was on account of having such false ideas
about me not knowing that it had to be done Jane and
the baby is doing very well I am so that I can just get around
as my feet & legs are swelled so but I am gradually wasting
away if there is any thing coming to Jane I think it is
the time for her to have it now to use as we have to live
very close and on the second quality of provisions and the cold
weather is coming on and no coals to keep ^(out) freezing
